**1) ENTRIES:** P - \$250, T - \$230, PT - \$210, E - \$200. *HST, drug, ambulance, and "Building Ontario One Event at a Time" fees included in entry.* All levels please add \$15 CE Levy. Enter online at [www.evententries.com](http://www.evententries.com) and pay secretary via e-transfer or send entries to secretary, at address above before Closing Date. **ENTRIES PAID IN FULL BY SEPT 17 RECEIVE A \$10 DISCOUNT.** Cheques payable to Grandview Horse Trials. NO POST DATED CHEQUES. **Proof of membership & Digital Horse Recording (T-I) must be emailed to Secretary.** Completed entries received after the closing date may be accepted subject to a \$40.00 late fee. Entries will be limited to the first 160 paid entries.

**REFUNDS:** Before closing date, refund less \$30 admin fee; after closing date NO REFUNDS. NO EXCEPTIONS. Stabling refund before Sept.14 unless stall can be filled. Withdrawals must be made in writing via email. Telephone withdrawals will not be accepted. Neg. Coggins Test required within 12 months if stabling. If the competition gets cancelled for any reason after it commences – no refunds will be issued.

**2) TIME SCHEDULE:** Sept 29, 3:00pm - course and office open. Sept 30, 8:00am - [P, T, PT, E] dressage; 10:00am - [P, T, PT, E] show jumping; 11:00am - [P, T, PT, E] XC. Start times available Sept. 28 at [www.grandviewfarm.com](http://www.grandviewfarm.com) or [www.horsetrials.on.ca](http://www.horsetrials.on.ca) . If entries warrant - Intermediate D & SJ may run on Saturday.

**3) OFFICIALS:** TD: Jennifer Franks; XC CD/CB: Bob Holman; Stad.CD: Sarah Irving; JUDGES: DRESSAGE: TBA, SHOW JUMPING: TBA.

**4) STABLING:** Stabling very limited- enter early for on-site stabling, 20 10x10 portable stalls only. \$60 incl. HST/stall per night (6pm-6pm). Stall doors, initial bedding provided. Stalls must be cleaned out before leaving. If on-site is full then call for local stabling availability.

**5) DRESSAGE:** P : FEI CCI/CIC 1\* Test A; T : Test 1; PT : Test 1; E : Test 1. ARENAS: P -20x60m; T, PT & E -20x 40m. Sand/ Future Track footing.

**6) CROSS COUNTRY:** P - 2800m @ 520mpm; T - 2400m @ 450mpm; PT - 2000m @ 400mpm; E - 1800m @ 350mpm. TERRAIN: Excellent sandy footing, rolling terrain. All courses inviting and of moderate difficulty; always adding new jumps at all levels.

**7) AWARDS:** Plates or coolers to winners. Ribbons to 8th place.

**9) DIRECTIONS:** From Hwy 11 North of Barrie to Oro Line 9; go over overpass West to Bass Lake Road (3rd stop sign). At 'T' junction, turn right and .5 km to Oro Line 10. Turn left to 2<sup>nd</sup> farm on right 1km. From Hwy 400, take Horseshoe Valley Road East past Coulsen to 10th Oro (at Jarratt). Turn right on 10th. Farm 2km on left.

**10) OTHER INFORMATION:** Vet on call during endurance, farrier and medical on grounds. Refreshments available on grounds. Children **must** be accompanied by a responsible adult. Dogs are welcome but must be on leash. Loose dog fine of \$50 will be donated to Course Building Fund. Stabling sometimes available for other events in the area. All competitors must have pinny holder. Additional parking added in south corner of property with new entrance.
